# Market Surveillance in China

#### How do officials perform quality Supervision in China?







- Enforcement: At the ports, never at domestic market
- Frequency: 50-100% or at the discretion of officials by HS code
- Violation disposition: Recall/ Destruction/ Media exposure





- Enforcement: At manufacturing stage/ domestic market
- Frequency: Seasonal
- Violation disposition: Recall/ Destruction/ Media exposure





- Enforcement: At domestic market
- Frequency: Very frequent
- Violation disposition: Fine based on multiples of retailed value/ Product withdrawn/ Media exposure






- Enforcement: At domestic market
- Frequency: Follow consumer complaints and concerns
- Violation disposition: Media exposure





# Standard System in China

### What standards do officials for quality Supervision in China?





When there are more than one standards applicable to the product with common parameters, the most stringent requirement would prevail.

#### What is GB? What is GB/T and FZ/T?





**GB** = **G**uo **B**iao (pronunciation in Mandarin)

#### Requirements for Textile & Apparel Products in China



According to "Chinese Standardization Law", the current standard for textile & apparel falls into two categories - Mandatory Standards and Voluntary Product Standards.

#### Mandatory Standards

Company or individual who participate in technical development, manufacturing and retail must comply with the regulation. Products that fail to comply will be prohibited to manufacture, sell in and import to China.

GB 31701 – Safety technical code for infants and children textile products

GB 20400 - Leather and Fur - Limit of Harmful Matter

GB 18383 – General Technical Requirements for Products with Filling Materials

#### Product Standards

Hundreds of product standards have been set up for different textile and apparel products in China. Once product standard has been declared or claimed for the product, the requirements specified under the declared voluntary standard shall be met.







# **Textile Products Mandatory Standards**



# **Mandatory Standard GB 18401**

National General Safety Technical Code for Textile Products





Chinese National General Safety Technical Code for Textile Products GB 18401 is adopted by

General Administration of Quality Supervision, Inspection & Quarantine of P.R.C (AQSIQ)

on November 27, 2003.

It standardizes general safety technical requirements for textile & apparel products, testing methods, rules of inspections, and guide for implementation and supervision.

This regulation has been in force since May 1, 2005

The latest version was published in 2010



#### GB 18401 classifies textile & apparel products into 3 categories:

#### Products for babies (<36 months)

#### Examples:

Diaper pads, underwear, bibs, pajamas, gloves, socks, coats, hats, beddings

#### Products with direct skin contact

#### Examples:

Underwear, shirts and blouses, skirts ,trousers , socks, bed sheets, quilts cover, towel, swimming suits, hats

#### Products without direct skin contact

#### Examples:

Coats, skirts, trousers, curtains, bedspreads, wall fabrics

# **Mandatory Standard GB 31701**

Safety technical code for infants and children textile products



This requirement would be effective on June 1, 2016 (with 2 years grace period for inventories made before June 1, 2016)



#### GB 31701 classifies textile & apparel products into 3 categories:

Products for babies (<36 months)

Textile products for consumer body height: < 100 cm

Products with direct skin contact (36 months to 14 years old)

Textile products for consumer body height: 100 cm - 155 cm(girls) or 160 cm (boys)

Products without direct skin contact (36 months to 14 years old)

Textile products for consumer body height: 100 cm - 155 cm(girls) or 160 cm (boys)

Plush toys, fabric handcrafts, single use hygienic products, luggage, bags, umbrella, carpets, and professional sports garments are out of the scope of this standard.



# **Mandatory Standard GB 5296.4**

Instructions for Use of Products of Consumer Interest - Instructions for Use of Textiles and Apparel



The latest version was published in 2012



The mandatory National Standard, GB 5296.4 applies to the use of instructions for textiles and apparel sold, distributed in or imported to China and has come into enforcement since January 1, 2000. Latest version was published in 2012.

The "instruction for use" of textile & apparel must contain a qualified certificate showing the product is complying with:

- GB 18401 the safety category
- Product Standard (FZ/T xxxxxxx)
- Details listed in the table below

Details of Manufacturer (in China)	* Care Instruction
Product Name	* Fiber Composition
* Product Size	Country of Origin – for imported products

<sup>\*</sup>Remark: these instructions must be displayed on permanent label

There are two other requirements depending on the feature of products

Attention to use and storage conditions

Period of use (products with deadline / expiry date, such as functional apparel, etc).



#### Ways to show the instruction for use:

- 1) To be printed or woven into products
- 2) To be printed on the care label
- 3) hangtag directly attached to products
- 4) hangtag, sticker or Fixed label on the package of products
- 5) To be printed on the package
- 6) Leaflet delivered with products

# Textile – Identification of Fiber Content GB/T 29862-2013

# Mainly to specify:

- Generic name of fiber
- \*The way to show fiber content




FZ/T 01053 was quoted in GB 5296.4-2012 for fiber content, but GB/T 29862 should prevail.

#### Fiber Content Requirement – GB/T 29862



- Description MUST be in Simplified Chinese while additional language is optional.
- No textile or apparel product may be described as '100%', 'pure' or 'all' unless it is exclusively composed of the same fiber; no similar terms may be used.

#### Fiber Content Requirement – GB/T 29862



Product composed of two or more fiber shall be disclosed with generic name, and percentage of all fiber, listed in the dominance descent by weight or sequence regulated.

Example: (Actual Content: 87.5% Cotton, 12.5% Polyester)

#### Fiber Content Requirement – GB/T 29862



#### Exemptions 豁免范围:

- For the part that is decorative in the product, inner part or certain trim, e.g. lace, frilling, binding, facing, waist belt, sash, collar, cuff, rib, elastic top, interfacing, padding, pocket, liner cloth, trademark, partial embroidery, appliqué, joining thread, and partial filling material etc., the fiber content can be not indicated.
- If the area of single part or total area of several parts of the same fabrics exceeds 15% of the product surface, the fiber content of the part shall be indicated. Except interfacing, padding and liner cloth.

## Fiber Content Requirement – GB/T 29862



\* Tolerance between the claimed fiber quantity and that with actual analysis

- 5 Symbols MUST be listed according to the below sequence.
  - Washing
  - Bleaching
  - Drying
  - Ironing
  - Professional Care
- Text description is optional but MUST be in Simplified Chinese. Additional language is optional.

# Textile Products' Size Labels

#### Size Label



► Size presentation for various types of textile products :

Garment : GB/T 1335 or GB/T 6411

• Cap or hats : FZ/T 80010

Hosiery : FZ/T 73001

Gloves: fitted hand's length and palm's width

• Bedding, scarf, towel or curtain: major dimension such as length and width

• Other textile product: according to own characteristics, such as length, width or weight.





#### **Size Label - Garment**



➤ Sizes labeling should be according to the requirement of the designated size standard in adopted product standard

• Children garments: GB/T 1335.3-2009

Men garments: GB/T 1335.1-2008

Women garments: GB/T 1335.2-2008

Knitted underwear: GB/T 6411-2008









#### **Size Label - Children Garments**



- $\bullet$  GB/T 1335.3 divides infant and children size into 4 <u>categories</u> with respect to body height. GB/T 1335.3  $_\circ$
- Each category is composed of different <u>classes</u> with respect to body height and girth (Chest/ Waist circumference).
- There is NO classification of Body Type.
- This standard does not cover <u>knitted</u> underwear which should be referenced to GB/T 6411.

#### **Size Label - Adult Garments**



- ► Each category in GB/T 1335.1 or 1335.2 is composed of different classes according to body height and girth (Chest/ Waist circumference).
- ► For Men and Women garments, they are divided into four body types, which are Y, A, B, and C. These body types are based on the difference between the chest circumference and waist circumference.
- ► This standard does not cover <u>knitted</u> underwear which should be referenced to GB/T 6411.
- ► For unisex garment, it is acceptable to use either man or woman series provided that it is clearly labeled as unisex product.


- ➤ Size designation is indicated in both the upper garment and lower garment respectively .
- ► Height and Girth (or Size and Style) are separated by an oblique line.
- **Examples**:
  - Upper garment  $150/68 \rightarrow 150$  (body height); 68 (chest girth);
  - Lower garment 150/60 → 150 (body height); 60 (waist girth)

## Size Label – Hat or Cap



- ► According to FZ/T 80010-2007 "Clothes-survey method for human body head round and size destination for headwear."
  - Use head circumference in centimeters as size designation.
  - Ranged from 44cm to 64cm, 1 cm increment.

## ► According to FZ/T 73001-2008

#### Hosiery with Heel Flaps

- Sizing is indicated by sock code which is Sock Length in cm
- For infant hosiery, when sock code in this standard is not applicable, size could be determined by the manufacturer per FZ/T 73025 "Knitted garment and adornment for infant".
  - e.g. 0-6 months, sock length: 6-8 cm.

#### Heelless socks

 Sizing is established by manufacturer to indicate the suitable range of body height or sock size code according to the total length measured in cm.

#### Stockings

- Sizing is established by manufacturer to indicate the suitable range of body height and hip size in cm.
- Permanent label may not be used if it has an impact on the use of the product.



# **China Textile Product Standards**

## **China Textile Product Standards**



- Every Style has to pick up suitable Product Standard and claim on the hangtag before entering Retail Market according to China Law.
- ➤ After choosing one **Product Standard**, BQTS and AIC will perform pick up inspection randomly based on this claimed **Product Standard**.
- Most Product Standard includes Mandatory Standard, and add some test items according to product characteristics.
- ➤ For Soft Line part, most product standard includes GB 18401-2010. Below is the example for popular Product Standard FZ/T 81007 <Woven Casual Wear> can use for most woven style above 2 years old.


